2022/23 Dues

Invoices have been sent for the 2022/23 dues. Due to an increase in insurance premiums, dues are \$112 for regular members and \$61 for Life/Honorary Life members. Members delinquent for this year will be dropped on March 15; however, if a member chooses to reinstate within 60 days, he or she just has to pay the delinquent dues.

Remember—you will need the 2022/23 purple member card to enter the Lodge and use the facilities effective on April 1st.

A note about you new membership card:

Our Lodge year ends March 31, if you have not renewed your card by April 1, by Grand Lodge statue, you will be denied Lodge and club access. Don't wait to the last minute to pay your dues, there is no grace period. If you do not have your new card and wish to enter the Lodge on April 1, either bring a receipt of prior payment, a check, cash or credit card to make you dues payment. At the door we will have a list of those from which we have received payment, unfortunately there are occasions where payment has been made but we have yet to receive it. So please, avoid embarrassment and pay your dues early.

Please note that your new card (purple) will not open the door before April 1, please keep your old (green) card till then.
